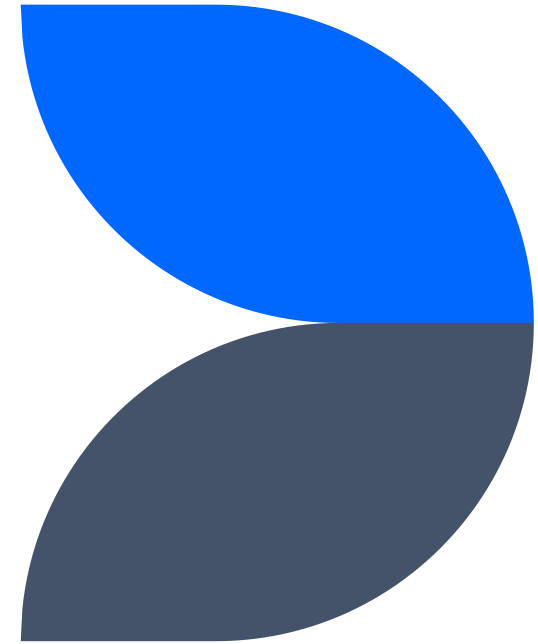

Why should you be a GFOAT Annual Partner?

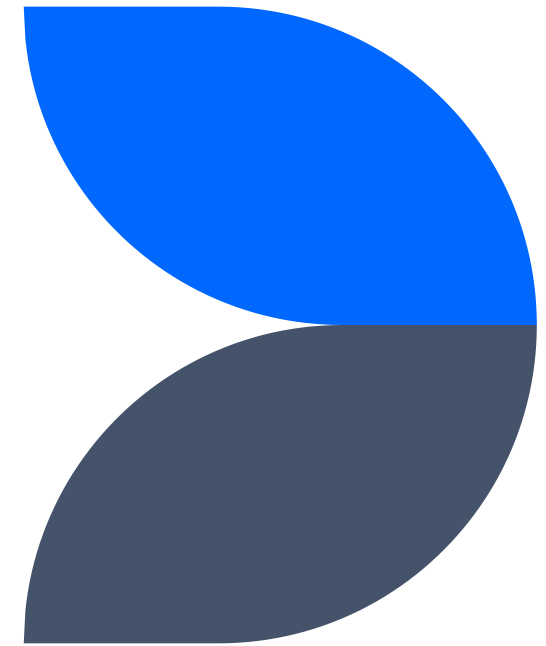

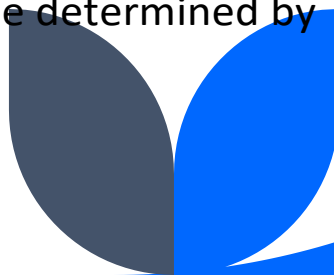
